新的評級方法基於內部評級實踐對原有評級方法開展的檢討進行了修訂,主要變化包括調整了評級框架及其中部分的評級指標(包括定性、定量指標及少數指標的權重和閾值);調整了評級打分卡模型,並為定性評級要素(含外部支持評估)等提供了更為具體的評估指引,以更好地區分不同受評對象的信用品質和打分模型結果的有效性。
