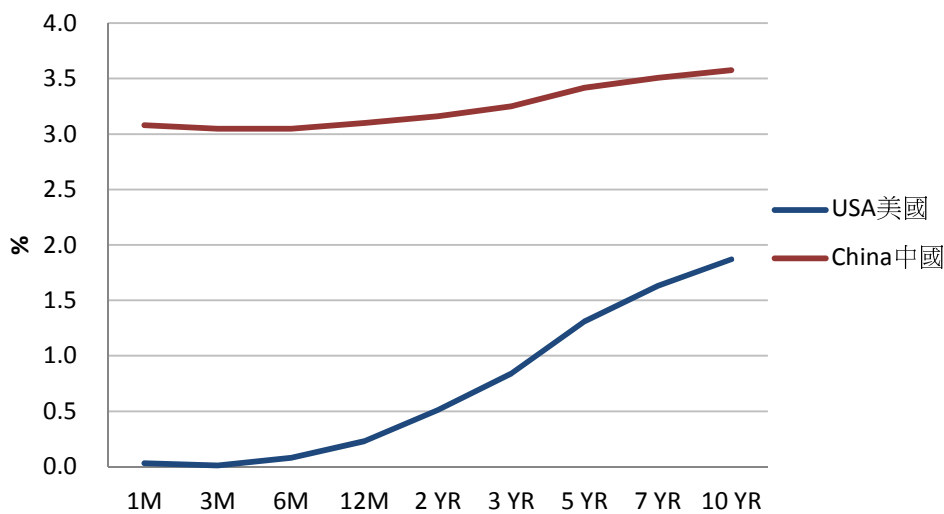

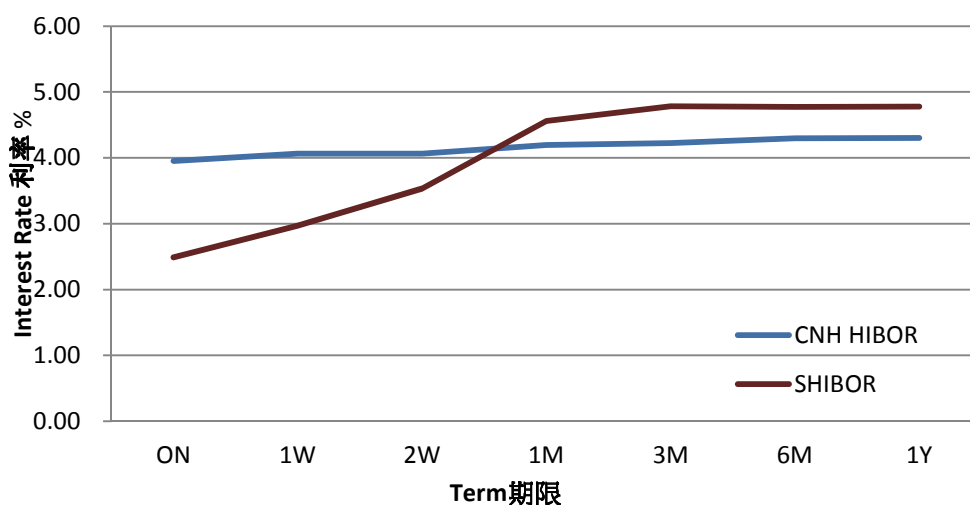


CNH HIBOR and SHIBOR Spreads

As of 17 April 2015, the CNH HIBOR fixings were higher than that of SHIBOR for tenor of overnight and one week and two weeks while the CNH HIBOR fixings are lower than that of SHIBOR for tenors of one month, three months, six months and one year.
